Introduction

As this last activity progress report overlaps in time with the overall SAMPLE final report, the Coordinator decided to give more space here to explain the activity of management in the last period of the project.

The scientific and dissemination reports have been summerised in the Final report of the SAMPLE project.

The reports of the WP1, WP2, WP3, WP4, and WP6 activities are available in the Final Report.

At month 36, the main project's results have been presented within the SAMPLE Final event and during the SAMPLE Session at the NTTS Conference, which took place in Brussels on 24 February 2011.

WP5: Management (01/09/2010-30/04/2011)

During the last period, the DSMAE Coordination Team has been engaged both with the ordinary management of project activities (monitoring RTD and Dissemination activities) and with some extraordinary activity regarding the financial management, i.e. the Amendment for the Grant Agreement and for the redaction of the Final Report and Financial Statement.

General and specific management

• In the last period the Coordinator has been engaged with the procedure for the **Amendment** of the Grant Agreement. The SAMPLE consortium included **a new Partner**, the University of Southampton, as partner n. 10, from 01/09/2010.

The pre-request for Amendment was sent to the Project Officer by email on the 23/11/2010.

The new Annex I was approved by the Commission on 10/12/2010.

The request was sent by mail to the EC on the 30/12/2010.

The first session in NEF was submitted on the 17/02/2011.

The last session in NEF was submitted on the 15/04/2011.

The procedure is now pending because of a problem of validation of partner n.9, which changed, in the meantime, its Legal Status.

Since the end of May 2011, the Final Report submission has been blocked for this reason.

The Coordinator informed step by step the Consortium about the situation.
